- 2. If you choose to mail-in your rebate request:
  - Complete ALL information on the rebate form including model number and serial number for each product. Incomplete forms will not be processed. Circle the models purchased on the rebate form.
  - Include the retail invoice or sales slip (photocopy acceptable) which shows the model number, store name of where the appliances were purchased and date of purchase.
- 3. Rebate submission must be submitted online or postmarked no later than November 17, 2014. Late submissions will not be accepted.
